PRESIDENT'S REPORT

• President Evers gave a report for 2013-2014.

SECRETARY'S REPORT

- June 24, 2013 minutes submitted by Liz Rubitski
- Motion to approve by Richard Dakin
- Minutes were approved unanimously

LAKE HEALTH REPORT

 Maureen Plumleigh gave a report on lake health and suggested a weed killer that could be made from 1 gallon vinegar, 1 cup Dawn dish washing liquid & 2 cups Epsom salts; several association members mentioned that they had tried it and it worked well.

TREASURER'S REPORT

- Lynn Roberts presented the financial statements
 - Proposed budget for 2014-2015 attached (Appendix I)
- Questions from association members
 - How many people haven't paid their association dues and what can we do about it?
 - ~32 owners have not paid & after 365 we put a lien on the property, interest rate is 1.5% a month (or 18% annually) until it is paid
 - o How do we trace if someone doesn't pay & they sell their property?
 - Lynn Roberts gets a call from the attorney or the insurance company; liens follow the property and not the property owner
 - o What are we charged to put a lien on the property?
 - \$18 because we are a municipality
 - o What is the \$9,000 budget item for if the town plows our roads
 - Dave Evers explained that we pay for the 13 association roads and the clubhouse to be plowed
 - o How do we get towns to take over ownership of the roads?
 - Association would have to bring them up to town standards which means widening them. This takes away from peoples yards.
 Drainage has to be installed as well.
 - A question regarding how the town plows in front of an owners property.
 - Dave Evers said to call the town & discuss with them. When he has spoken with the town about this before, they have explained why it

has to be plowed in a certain way but this may be different depending on the property location.

- o What does road re-grading do?
 - Smooths it and fills in the potholes
- o If someone tries to rent the clubhouse and owes us taxes, do we let them?
 - Lynn Roberts has begun to monitor this
- o Is our insurance more expensive because we rent the clubhouse out?
 - We will follow up on this but we don't think so because it is known that the building will get public use.
- Motion made to approve the 2014-2015 budget as presented by Earl Peters & approved unanimously
- Motion made to set the mill rate at 1 for 2014-2015 fiscal year by Marie Feinberg & approved unanimously

OLD BUSINESS

- Association member asked about dogs swimming in Haines Park, what can we do?
 - Haines Park is not part of the association and a call to the Town of Old Lyme would be the best course
- Question was asked about a large snake seen in Rogers Lake & it turns out it was a water snake.

NEW BUSINESS

- Member asked about some street signs with illegible letters.
 - Call the town that the sign is in as they maintain street signage
- Overgrowth at Huntington Bay was questioned
 - Dick Smith, President of the Rogers Lake Authority, responded as this is a RLA issue. He said he puts it in the budget every year, but it gets denied.
- Can we get a grant to dredge Huntington Bay?
 - Rogers Lake Authority would have to look into that
- Member mentioned that we still need the town to extend the burm in front of 43 Rogers Lake Trail
- Question regarding bank owned properties in the association and what to do if the upkeep is behind
 - o Call the bank & request that the maintenance be done
- Member mentioned that some folks have a lot of junk cars and there are companies that will remove them for free.
- Member requested that Lone Pine Trail be added to get trees and bushes trimmed.
- President Evers called for a motion to approve the slate of officers for 2014-2015
- Earl Peters motioned to approve and it passed unanimously

Motion to adjourn by Kristin Vernon. Meeting adjourned at 8:11 p.m.
